CRITERION I – CURRICULAR ASPECTS

1.1 – Curriculum Planning and Implementation

1.1.1 – Institution has the mechanism for well planned curriculum delivery and documentation. Explain in 500 words

Belda College is affiliated to Vidyasagar University and follows its prescribed Curriculum. The different ways through which the Institution devises mechanisms for well-planned curriculum delivery and documentation in the offline mode are:

1. Under the supervision of IQAC and Academic subcommittee the Academic Calendar is prepared in compliance with the academic calendar published by the affiliating University prior to the commencement of Academic Session which is uploaded on the college website.
2. The Routine Committee with IQAC prepares routine (UG & PG) for the present academic session which is discussed in the Academic subcommittee meeting and after approval is distributed to the respective Heads of the Departments and is displayed on the Departmental Notice Boards.
3. The Principal, Co-ordinator, IQAC and the Academic subcommittee conduct a meeting at the beginning of the session to discuss the strategies for effective implementation of curriculum like fixing schedule for Internal Assessment, evaluation process, teaching-learning methods, implementation of PO & CO etc.
4. Departmental Heads conduct meetings before the commencement of classes with their respective faculty members for preparing departmental routine based on the master routine, allocation of class and syllabus which, after approval in the DC Meeting, is communicated to the students.
5. Following the Syllabus allotted & class routine, respective teachers prepare their Annual Lesson/Teaching Plan and conduct their classes accordingly. Such records are maintained in the Teacher's Diary.
6. Student's attendance records are maintained by the respective departments.
7. Each department has its own Seminar Library for students and Faculty members.
8. Teachers predominantly use the traditional method for teaching, i.e., chalk and talk, lecture method. However, during the lockdown period teachers resorted to remote teaching whereby Online platforms like, Google Classroom, Google Meet, Zoom, WhatsApp video calls were used for conducting online classes.
9. Faculty members also

supplement their online teaching with special lectures, webinars, project works. 10. In order to prepare students with the new system of online examination & to keep a track of the progress of the students, continuous evaluation like regular online class tests, mock tests, internal assessment etc. has been conducted. The evaluated answer scripts and the marks are preserved in the e-mails, Google Form, Google Drive, Google Classroom 11. After commencement of classes, teachers identify slow learners and advanced learners through continuous evaluation and conduct remedial classes for slow-learners where their progress is measured through assignments which are regularly checked by the teacher preparing them for University Examinations. Advanced learners are provided with advanced study materials, guided to develop research aptitude, and prepare them for University and Competitive Examinations by making them solve previous years' question papers. 12. Online Quiz, extempore speech competitions, poster/paper presentations, preparation of e-magazines etc. are regularly organized by Departments to facilitate all-round development of students. 13. Activities of the departments are recorded and stored in the form of soft and hard copies 14. The library provides easy access to printed books & journals, e-books, e-journals & e-contents to students and teachers through the college website for an uninterrupted teaching-learning.

1.4.2 – How the feedback obtained is being analyzed and utilized for overall development of the institution? (maximum 500 words)

Feedback Obtained
<p>For the academic year 2019-20, IQAC, Belda College collected feedback (Online Offline) from Teachers, parents, alumni, employers and students. We received feedback from a total of 45 Teachers, 92 alumni, 273 parents, 591 students and 10 employers. The alumni were given a questionnaire consisting of 11 queries seeking to know their views on their Alma mater and how they would like to contribute to its development. More than 50 Alumni expressed their high satisfaction towards the Institution's infrastructural, Library facilities and</p>

more than 90 expressed that they feel proud to be associated with Belda college as alumni. The parents were given a questionnaire consisting of 11 queries seeking to know their views on the facilities for study, extension services etc. More than 50 Guardian strongly agreed that the college has helped in moulding their children's personality, the curriculum has helped in developing their children's rational outlook and overall performance. As for the students, they were supplied with four questionnaires, one each for evaluation of teachers, library and administration, programme of teaching and curriculum etc. The students were asked to evaluate the teachers on the basis of their sincerity/commitment, regularity/punctuality, communication skills, use of ICT, coverage of syllabus. They were asked to evaluate the college administration and library facilities, cleanliness of classrooms, toilets, canteen, quality of and access to drinking water, food etc. More than 70 students have expressed that 80-100 syllabus was completed and were satisfied with the teaching-learning, evaluation process, library and canteen facilities. Teachers were asked to provide feedback on the curriculum, teaching facilities, availability of books in the seminar departmental library. The feedback received from Teachers, alumni, students and their parents constitute an essential input in the decision-making process of the college. After the collection of feedback, a draft report was prepared providing a comprehensive account of all the responses received and then discussed and analyzed for preparation of a final report detailing the various responses received along with the main recommendations by IQAC. The final report was shared with the Principal, HODs and various administrative bodies functioning in the College for their cognizance and appropriate actions. The basic demands compiled from the feedback received from the teachers, students, parents and alumni during 2019-20 and on which the Principal agreed to initiate action in the following academic year include: 1) To open Research Centre in the college 3) Fee concession for existing students (UG PG) in different courses for admission and examination. 4) To provide access to online library services and e-books for students and faculty members 5) To proceed for the 3rd cycle of NAAC accreditation. 6) To organize more extension activities during the pandemic situation 7) To organize faculty and student enrichment programmes like webinars, periodical/Special/Extension lectures, by the respective departments 8) To increase virtual practical classes. 9) To take initiative for Deserving Teachers' Promotion under CAS. 10) To organize career counselling and campus placement programmes. The Principal met with the HODs and teachers to deliberate on their performance.

Mentoring is a very important part of teaching – learning and evaluation process. Mentoring system enhances Human values as enshrined in our constitution like justice, liberty, equality, fraternity, human dignity etc. This system is very important in providing the teachers assistance to the students in matters related to their career and issues in personal, academic and financial matters. Mentors provide impartial services to all the students of our college having varied socio- economic background. Mentorship for our students has the following aims and objectives: To develop teacher-student relationship To guide a particular student and offer suggestions during his/her tenure as a student of the college on various matters To help a student grow as an ideal citizen of the nation and as an ideal human being equipped with values and morality To help the mentees in different kinds of difficulty faced by them while pursuing their study To guide the mentees for progression to higher studies or employment To encourage students for class attendance To boost up students for better academic performance and progression To reduce student drop-out rates To identify slow learners and to take necessary steps and to inspire advanced learners The institute has followed the suggestion made by IQAC, Belda College to introduce the mentoring system. The importance of integrating the system for improving students' performance is immense. The system was promptly and effectively put into practice after it was first introduced from the 2015-16. The mentoring system assures a better understanding of individual students' potential and brings out their highest performance. The IQAC had taken the initiative of implementing the mentoring system of students. Students are categorised based on the streams of studies and also according to their core/ general subjects. They are divided into groups of 30-40 students depending on the number of students. Each group is assigned a particular Mentor- Professor who would perform mentoring classes. We have approximately 3500 enrolled students at our college. With an objective of bringing all the students under a mentoring system, each mentor is assigned 30- 40 mentees under his/her supervision. During the COVID 19 pandemic lockdown situation online mentoring class was implemented through Zoom, Google Meet, Google Classroom, Whatsapp, phone call etc.

2.5.2 – Reforms initiated on Continuous Internal Evaluation(CIE) system at the institutional level (250 words)

1. Students were oriented on evaluation and assessment system, as well as developing research aptitude and methodology-based project work/dissertation and field work during the Induction Programme in the offline mode. However, the session 2019-20 has been divided into 2 phases where both online and offline mode was applicable. The odd semester students (1st, 3rd 5th) appeared for the offline examination held in the college campus before the lockdown. However, after the outbreak of COVID-19 pandemic, the conventional offline classroom examination system was replaced by online examination as per the revised VU examination guidelines for all programmes and courses (UG PG). 2. For evaluating the students progress different departments resorted to different mechanisms. While oral tests were conducted during the online classes arranged on virtual platforms like Zoom, Google Meet etc. Whereas, for written tests faculty members used different kinds of Learning Management Systems like Google Classroom, Microsoft Team etc. Home assignments were given in Google Classrooms, Whats app groups and through emails. Class tests (Open Book System) were often conducted using mostly short answer type or MCQ type questions. Evaluation was often conducted through Google form, emails, WhatsApp chat box, Google classroom, G-suite video conferencing, Zoom etc. 3. To supplement conventional evaluation process certain Departments organized various activities in both offline mode and online interactive platforms, such as

Poster presentation, Online Essay Writing Competitions, Online Quiz Competitions, Webinars. 4. Due to lockdown, the internal assessment of end semester under CBCS pattern was conducted online. UG PG question papers blank answer scripts were provided to the students online through the college website and VU website. As per the University guideline, internal examination for final year/semester students was conducted online where 50 per cent marks was given by the college and 50 per cent by the COE department. 5. For University examination, final year (3rd Year 6th Semester) students downloaded the question papers and answer booklets from the college/ University Examination Portal. After writing the answer, they were instructed to send the scanned copy of their answer sheets through email to the respective departmental mail id, specifically created for the concerned examination. Students were communicated regarding the email ids through college website.

2.5.3 – Academic calendar prepared and adhered for conduct of Examination and other related matters (250 words)

Belda College is affiliated to Vidyasagar University. The College prepares a tentative Academic Calendar in compliance to the Academic Calendar given by the affiliating University prior to the commencement of Academic Session. The Holiday list is prepared taking into consideration University holiday list, the local festivals and Colleges own requirements. Based on the Academic Calendar prepared, the college schedules its activities such as admission, teaching days and all its Examinations. Following the instructions of the affiliating University, B.A./B.Sc 1st semester Honours and General classes commenced from 2nd week of July 2019 and classes of B.A/B.Sc. 3rd semester and 3rd year Honours and General classes commenced from 4th week of July 2019. Class tests are conducted after commencement of classes, decided by the individual departments as per the decision taken in the Departmental Committee meeting and the Academic Calendar. The Class-Tests are undertaken to identify the students for remedial classes, slow learners and advanced learners. However, with the outbreak of the Corona Virus pandemic followed by the lockdown, the affiliating University issued a revised Academic Calendar that instructed to conduct examinations through the online platform, which was followed by the college. Consequently, abiding by the instructions of Vidyasagar University, Internal Assessments were scheduled for Honours and General courses each semester through the online mode. Theory and Practical Examinations for 1st sem, 3rd Sem, 3rd year Honours and General courses were held as per the notice of Vidyasagar University. All End- Semester Examination of PG Courses (Bengali, English, Physics, Mathematics, Chemistry and Geography) was scheduled online as per the instruction of Vidyasagar University.

1. Organization of Awareness Program on Covid-19 Pandemic through various Units: From the beginning of 2020, a novel coronavirus Covid-19 affected the people of almost all countries. Our country has been severely affected by this SARS virus. It was an utmost challenge for the Government to curb the spread of this deadly infection. It was not possible for the government alone to fight against the spread of the coronavirus. It requires cooperation from all walks of people. People got both directly and indirectly affected by the pandemic. It should be fought unitedly together with the help of the Government. Our college also voluntarily came forward to actively help the distressed and affected

people in this pandemic situation. Immediately, the IQAC and the Principal responded to this emergency situation and decided to organize Covid-19 awareness programs, seminars and relief distribution. For this purpose the Principal of the College decided to involve IOAC members, local teachers, NSS Programme officers and volunteers, NCC units, Students' representatives, Head of office staff, representatives from local communities and local administrations. The objective was to smoothly conduct and supervise the implementation of the various awareness programmes taken from time to time to make the local people aware of precautions needed to be taken to remain safe and protected from the deadly virus. A good number of awareness programs, poster making program, quiz competitions, awareness rally, seminar etc. were organized through the active involvement of various bodies and units of the college and local people. This shows a good practice of decentralization and participative management. 2. Covid-19 Relief Distribution and organization of Relief Camps: Due to the corona pandemic situation, many local villagers in Belda failed to make their ends meet due to the prolonged lockdown and closing of commercial activities. There was also the problem of migrant laborers. In this situation to help the local people, on the recommendation of the IQAC, a committee was formed by the Principal consisting of IQAC members, Senior teachers, Programme officers of NSS and NCC units, Head of Office, Representative from students, representative from local Panchayet body. A Covid-19 relief fund was created by the Principal with contributions from the employees. A Relief distribution camp was organized by the college inside the college premises. Voluntary services were rendered by distributing relief, food, medicines and essential materials to the local villagers. The relief camp was successfully conducted with the active participation of teachers, office staff, students, and volunteers of NSS units. Many of our students were actively involved in distributing relief materials in their locality maintaining Covid-19 Protocols with the active help of college authority. Some of our students also rendered their services to the corona affected people by helping them to get medical treatment and other essential requirements. It would be worthy to note that the college has collected contributions from all its employees and made a donation of Rs. 1,25,000/- to the Chief Minister Relief Fund. Also the College has spent more than fifty thousand rupees towards various relief works.

Since March 2020 to December 2020, all examinations, evaluation as well as assessment were taken online as per VU guidelines. 3. The teachers of the College are actively engaged in the evaluation process of the University as Paper setters, Examiners, Head-Examiners, Reviewers, Moderators etc. 3. The College has set up a separate Examination Cell for Post-Graduate Departments. 4. Tutorials in offline online mode as well as online class tests, mostly MCQ based objective tests/short answer type, quiz, student seminar etc. was conducted through Whatsapp, chatbox, email, zoom video conferencing and Google Workplace (Google classroom, GSuite video conferencing, GMeet Chatbox, Google Forms, Google Sheets etc.) for both UG PG courses.

Teaching and Learning

Workshops, seminars, webinars and regular use of ICT in the classroom contribute to the enhancement of Teaching-Learning experience in the College. 2. Lectures as well as webinars on Covid-19 awareness, environmental consciousness and sustainability, gender sensitization, ethics and morality are regularly arranged. 3. Due to the emergence of pandemic situation from March 2020, teaching and learning process has been continuing in online mode (Zoom, Google Classroom, Google Meet, e-mail, WhatsApp, Audio conference etc). 4. Tutorial classes and remedial coaching are provided to the slow-learners while

advanced-learners are supplied with advanced study materials in both offline and online mode . 5. The Faculty members are encouraged to update their knowledge through their participation in Seminars, Webinars and Conferences. They are also encouraged to pursue Research work. 6. Depending on the performance of the students in online class-tests, the drawbacks of the students are identified and suggestions are given for improvement. 7. The College focuses on experiential and participative learning.

Curriculum Development

As the College is affiliated to Vidyasagar University, there is very little scope for Curriculum Development from the part of the College and the College implements the curriculum designed by the University. 1.Senior faculty members who are part of the Undergraduate Board of Studies of the Affiliating University or Postgraduate Board of Studies of the College function for Curriculum Development through their participation in Workshops organized by the University for revision and restructuring of the Curriculum. 2.The College includes field work, industrial visit and educational excursion at both Undergraduate and Postgraduate levels to enrich the curriculum. 3.Different departments offer Add-on courses, the syllabus of which are designed by the Faculty members of the College. 4.Teachers try to enrich the curriculum by involving the students in project work, group discussions, Students Seminar, Wall Magazine preparation, online quizzes etc.. 5. Due to Covid-19 outbreak and total transition from offline to Online mode of teaching from March 2020, syllabi of the different courses were reduced and teaching has begun to be conducted online through Google classroom, Google meet, Zoom, Skype etc.

7.1.7 – Initiatives taken by the institution to make the campus eco-friendly (at least five)

1. The initiative of low firewood practices, especially in the college canteen has helped in reducing carbon content to a great extent. 2. The Save Paper Campaign has been largely efficient in saving paper among the students and staff. 3. Plantation of a large number of saplings, especially on 5th June and through different environmental campaign by NSS is a moving step in going green and maintaining an eco-friendly Green campus. 4. More use of LED bulbs instead of incandescent and CFL bulbs in a partial block of the college campus have

significantly reduced the usage of energy consumption. 5. There have been plans to ensure carbon neutrality in the college campus through Vermin-composting and Solar panel. 6. The institute ensures restricted entry of automobiles and promotes more use of bicycles and battery-powered vehicles (e-rickshaws). 7. The college is equipped with a more walkable and pedestrian friendly pathways. 8. The college has pledged to measurably reduce plastic footprints in the campus, making the campus tobacco free and 'plastic-free' zone. 9. The campus promotes green infrastructure on campus, with pen spaces and natural landscapes for physical, mental and spiritual healing of the stakeholders. 10. With the view of cultivation of medicinal plants, a garden called 'Sushruta Uddan' was created, with around 40 herbal/medicinal plants tagged with their biological nomenclature. 11. Rainwater harvesting is another eco-friendly initiative that measurably reduces the dependence on ground water and electricity. It involves the collection of water that has fallen and is collected from the roof and subsequently stored for later use. 12. The use of clay pots and paper cups for tea in the college canteen is one of the eco-friendly initiatives. Clay pots as well as paper cups are biodegradable, eco-friendly, sustainable as well as healthy. 13. The use of Sal-leaf plates for meals for the students and staff in the college canteen has been another eco-friendly initiative. 14. The use of Solar energy is one of the eco-friendly initiatives which has remarkably reduced the operating costs in the college campus. Solar has been successful in providing a great source of reliable energy.

7.2 – Best Practices

7.2.1 – Describe at least two institutional best practices

BEST PRACTICE-I Student and Faculty Enrichment Programmes **GOALS** To help both the Teachers and the students broaden their skills, as well as their understanding of their field of interest. To allow Teachers and students to attain new knowledge on the latest developments in their own disciplines as well as on contemporary issues. To develop their interaction skills, rational faculty and public speaking abilities and prepare them for all round development. To offer both students and teachers the opportunities of being benefitted from alternative mode of having discussions on academic issues in the absence of the conventional face to face mode. **CONTEXT** Due to the sudden outbreak of COVID-19 pandemic, the institution has been compelled to shift from holding conventional mode of discussions on academic issues through seminars, conference, workshops, special lectures to virtual platform for the same purpose. National International level Offline and Online seminars on academic related issues i.e., to supplement traditional curriculum-based teaching were conducted to ensure uninterrupted allround learning enrichment of students and teachers. Furthermore, the unexpected extension of lockdown had not only brought forth a sudden shift in the entire Teaching-Learning process, it has simultaneously deprived students from enjoying their college life and being physically present in the college campus. Consequently, to motivate students, to make them feel an integral part of the college, several activities in addition to academic have also been organized. **THE PRACTICE** International, National State level webinars on Academic issues, Awareness Programmes related to COVID-19 pandemic, Mental wellbeing, Environmental issues, Gender Sensitization and imparting strengthening moral values where eminent experts from across the globe and country shared their expertise were organized for all the stakeholders of the college. Joint collaborative webinars, online Essay writing competitions were conducted involving Bangladesh Open University, Dhaka, Bajkul College, Basanti Devi College, NSS NCC UNITS. Special care was taken to keep the students physically active during this lockdown period. In this regard International Yoga Day was celebrated virtually on 21st June 2020, where Mr. Sukumar Pradhan, Principal, Yoga School of Contai Yoga Instructor, Athilagari, conducted 45 minutes session imparting valuable lessons on the

importance of yoga and exercise during this pandemic situation. To give the students an experience of relishing their college days, to understand their experience of this present situation, to provide them an opportunity to show their aptitudes to nourish their talents, numerous cultural, academic and extension activities were organized in the form of Online Poster Making competitions where students were given a prescribed format and a deadline according to which they were asked to click a clear picture of their essays or drawings and send them online in the given e-mail id. All the webinars were conducted through reliable web platforms, primarily through Google Meet Platform, Zoom which were live streamed on the Belda college YouTube channel and then later posted on the Belda college official Facebook page especially for those who were unable to be present, to increase their probability of accessing and participating in such activities. Records of all the activities are kept in both online and offline mode. EVIDENCE OF SUCCESS Total 23 (twenty-three) webinars were organized in the online mode and 9 (Nine) Seminars/ Special lectures were organized in offline mode. More than 2500 students from the college participated in the webinars and seminars Students and Teachers became more accustomed with this new mode of interactive platform. PROBLEMS ENCOUNTERED The major problems encountered were poor internet connectivity and ICT infrastructural constraints faced by many students and teachers residing in the remote areas. BEST PRACTICE-II Updated College Website Social Media Network GOALS In order to keep the communication system clear, reachable and student friendly during this sudden extended lockdown period. To transform the college notice board into e-notice board, which can be easily accessed by all the stakeholders of the college. To provide timely, engaging, and updated current information regarding college related activities like admission process, examination notification, University form fill up, Academic calendar, Seminars/Webinars to all the stakeholders of the college and community. To provide additional support to the college website through the college official Facebook page, twitter page and YouTube channel CONTEXT During the Pre COVID-19 period where the conventional offline mode was applicable, students would get information from the college notice board. However, with the sudden and extended period of lockdown such provision was disrupted. Consequently, in order to keep the communication system clear, reachable and specifically student-friendly during this sudden extended lockdown period, special care was taken to keep the college website and other official social networking sites like Facebook page, YouTube channel, twitter page updated with all the information, Notice regarding college, department and University activities. THE PRACTICE It was made sure that all the students and other valuable stakeholders are kept informed regarding all the upcoming activities, Programmes, examination and admission related information. Additionally, to support the college website, an official college Facebook page, twitter page and YouTube channel have been opened to disseminate all vital information to the stakeholders, especially the students. College programmes, webinars are live streamed in these social media platforms to extend support to students and increase their chance of accessibility to participation in various college activities, so that no students are left out from this new remote learning system. The entire process of updating the college website and official college social networking sites is done by a dedicated team comprising of teaching faculty and office staffs. EVIDENCE OF SUCCESS Majority of stakeholders of the college has been reached through e-notice boards of the updated college website and other dedicated official social networking sites. Students especially responded to the dedicated official social networking sites of the college by subscribing to the channel, following the college related page. Very few students visit college campus to seek information at present lockdown situation. PROBLEMS ENCOUNTERED Lack of a good Internet connection strength and recurring incidents of power cut in college area cause some delay to update certain information through the e-notice board. Lack of sufficient transport

facilities due to pandemic situation caused hindrance in the collection of data by the social media cell from college office for timely uploading.

7.3 – Institutional Distinctiveness

7.3.1 – Provide the details of the performance of the institution in one area distinctive to its vision, priority and thrust in not more than 500 words

Belda College aims to transform itself into a centre of excellence in the arena of higher education and strives towards the holistic development of the young learners basically coming from weaker sections of the society. Located in a rural setting, Belda college since its establishment in 1963 has played a pivotal role in providing opportunity and quality education to its immediate rural community members. Due to the sudden outbreak of Corona virus followed by the extended lockdown of all educational institutions and with the vision and mission of continuing to impart knowledge to the first-generation learners of Belda and adjacent rural areas, the college in this year has introduced certain new certificate courses, conducted extension activities to cater to the immediate needs of the pandemic affected people and implemented certain reforms practices in its Teaching learning Evaluation system during this session: Since the college is located in a tribal belt special the college is committed to empower the marginalized people through providing them quality education and enhancing their employability developing skills. To fulfill this commitment the college has introduced certain certificate courses like Horticulture, Mushroom Cultivation, Folk Santali Dance, Chhau Dance, Dairy technology. These courses are aimed at empowering the socio-economically marginalized people in the surrounding neighbourhood. Social Responsibility: The college has been active in extending support during COVID-19 lockdown period towards the local neighbouring community. Awareness Programmes in the immediate neighbourhood communities have been organized through miking leaflet distribution. On 9th October 2020, Belda college arranged a programme in its campus for distributing relief items (rice, pulses, cooking oil, one packet of soy bean, 1 packet biscuit) protective gears (1 mask, 1 bottle sanitizer, 1 Dettol soap bar) to the residents of the neighbouring 3 villages namely, Asram Para, Bandh Para Deuli Maddhya. The Block Medical Health Officer of Belda, Dr Ashish Kumar Mondal graced the occasion and delivered a lecture on the preventive measures to be taken during COVID-19 pandemic in local language. About 500 local residents were provided with the relief safety kits were educated on all the vital COVID-19 protocols to be maintained in order to stop the spread of the virus. The programme was telecasted on 'Update Bangla News' channel. Online classes were arranged on a regular basis. Care was taken to continue the newly introduced remote/online teaching learning and ensure maximum participation of students. Consequently, during the initial phase of lockdown only 2 classes per semester per day were conducted keeping in mind the infrastructural issues faced by our students. To supplement traditional classroom teaching and online/remote teaching, National and International Level seminars/webinars were organized in collaboration with other esteemed institutions for all round development of the students. Secondly, to keep students morally psychologically uplifted, physically fit and impart value education, the college continued programmes on moral education, psychological counselling, yoga training in online mode. In the offline mode, offline National/State Level Seminars/Lectures were organized by various departments. Extension activities were also organized.
