**Agenda 4: To ensure compliances of the orders of reservation and other benefits in favor of SC and ST.**



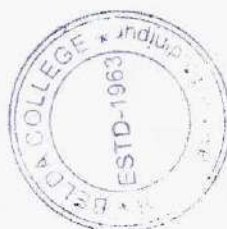

**Agenda 4: To apprise the students belonging to SC/ST category regarding the career opportunities available to them from the college.**


